Dear Mr. President,

I am sending to Members of F.A.I. and Delegates/Observers of C.I.V.L. copies of the C.I.V.L. Minutes of the meeting held in Kössen last September.

Regarding Item VI a), concerning World Championships rules, it is necessary to recall the following points :

Section 7 of the F.A.I. Sporting Code (Hang Gliding) was circulated last July, after having been approved by C.I.V.L., C.A.S.I. and Council. In accordance with the Resolution adopted in New-Delhi by the General Conference in 1970, all sections of the Sporting Code must remain valid for a minimum period of four years.

However, in the case of C.I.V.L. and since this is a completely new and evolving discipline, it should be possible to adapt certain parts of Section 7, while taking into account the new principles agreed at the General Conference of Tehran last October.

As was specifically agreed at the Kössen meeting, these adaptations concern :

(i) new definitions of the three Hang Glider Classes, in accordance with the actual "State of the Art" and in view of the experience gained at the First World Championships;


(ii) addition of new "tasks" to the two (duration and landing accuracy) which exist as of this date. This is a complement not an amendment.

(iii) introduction of a second "proficiency badge" to the elementary one already in existence (complement, not amendment).

(iv) provisions for setting up a panel of judges, as mandatory per Section 1 of the Sporting Code of F.A.I. (Art.S.1.1.), which also appear desirable in view of the future contents of the tasks in Hang Gliding World Championships.

The above additions or adaptations to Section 7 of the Sporting Code will have to be approved by C.A.S.I. at one of its forthcoming meetings.

- 2, Congratulations to all delegates for an exceptionally smooth, positive and cooperative meeting in Kössen. A great deal was accomplished during the most enjoyable two days' session and we now have the organization necessary to accomplish our goals.
- 3, Our Sub-Committee system is functioning nicely. It permits delegates to concentrate their time in those areas which interest them most and it confines detailed debate to the smaller informal "Working Groups".

Delegates are reminded that they have a responsibility to their country and to the C.I.V.L. to represent their own people and to participate in Committee Work., i.e. if you want something changed, you must do it. Here is the procedure :

- a, Write up your proposal with arguments and supporting documents and send it to the appropriate Sub-Committee Chairman. He will coordinate the proposal, duplicate it and send it to his Committee Members for comment. You and the Sub-Committee chairman may then work together on digesting the comments and drafting a revised document. If there is wide disagreement, it will be necessary to distribute the new document to the Committee again.

- b, The Sub-Committee chairman will send the completed project to the Secretary by 15th July, per the above calendar schedule. (so, you can see that time is short).
- c, F.A.I., Paris must distribute the proposal to all delegates and National Aero-Clubs six weeks prior to the C.I.V.L. Meeting, thus allowing everyone sufficient time to read, digest and debate it. Remember that in some countries, particularly the larger ones, the delegate must consult certain Committees or the national association on some important items. This takes time.
- d, The Sub-Committee, or "Working Group", will meet in Paris on 25th October 1977 and may make final minor changes to the document putting it in final form.
- e, the proposal is then presented to all the delegates for vote on 26th October 1977 at the Plenary session.

It is necessary to follow this formalized schedule in order to allow all interested parties an opportunity to participate.

Each delegate should serve on 1-2 Sub-Committees; pick the ones that interest you most. Let me know as soon as possible on which Sub-Committees you would like to serve. I shall assign you to the ones you wish as best I can considering regional representation and committee size. While committee meetings are open to all delegates, the size of the Working Groups must be kept reasonably small to facilitate work by mail between meetings. Remember, if all delegates were on all Sub-Committees, we would have a "Committee of the whole" thus defeating the purpose of the sub-committee system.

- 4, Many thanks to Secretary Harry Robb for the outstanding job in recording the Minutes and their voluminous attachments.
- 5, Recently, the F.A.I. published and the General Conference approved the official C.I.V.L. delegates list as reflected by their files as of 14th September 1976. Only 18 nations are listed and some of the names are unknown to the President. Delegates should check with their National Aero-Clubs to make certain they are listed properly.
- 6, Harry Robb, Chairman of the World Championships Rules Committee, is redrafting the competition rules to include items agreed upon at the September Kössen meeting. He has announced the following schedule :
 - 1 Dec. 76 : Draft to be mailed to the committee members and the C.I.V.L. Bureau (President and Vice-Presidents).
 - 1 Jan. 77 : Deadline for return of the draft with comments to Mr. Robb.
 - 15 Jan. 77 : Completed proposal to be sent to F.A.I. in Paris (six weeks prior to the C.A.S.I. Meeting).
 - 18 Feb. 77 : Completed proposal to be submitted to the C.I.V.L. Bureau at their meeting in London.
 - 2nd March 1977 : Completed proposal to be submitted to C.A.S.I. for approval.

Rod Murphy, South Africa, has generously offered to print this additional text as an Annex to Section 7 in both English and French. This should be accomplished prior to 1st May 1977. Informal photocopied versions should be available in March. More important, the Glider Class Specifications are attached to the Minutes.

- 7, Ann Welch, Great Britain, Chairman of the Proficiency Standards and Badge Design Committee, has completed the Section 7 Badge Annex and is obtaining price quotes on the design we agreed upon in Kössen. Delegates are reminded that the requirements for the Bronze and Silver Badges have been agreed upon, but that those of the Gold Badge have yet to be introduced.

Mrs. Welch has volunteered to draft the World Championships bid form so that potential hosts might know what is to be expected of them and so that we can more effectively evaluate all bids. The Hang Gliding World Championships schedule is as follows :

- I. 1976 : Kössen, Austria (completed)
- II. 1977 : Barberton, South Africa
- III. 1979 : France, Site tba.
- IV. 1981 : Great-Britain (Bid provisional).

- 8, Sub-Committee Chairmen are requested to send a status report to the President by 1st January 1977. The report should list all projects under consideration and their current status. Projects are not expected to be completed, we simply want to know who is working on what and what the progress is.
- 9, The C.I.V.L. Bureau is scheduled to meet in London on 18th February. Facilities are being provided by the Royal Aeronautical Society.

I. ADOPTION OF THE AGENDA

- a) Discussion of V.e) (Rogallo) and V.g) (World Championships) was moved to Item VI (New Work.)
- b) Mr. Sepp Himberger extended an invitation from the Mayor of Kössen to lunch at 1230 at the Post Hotel.
- c) Mr. Bertrand Larcher invited Delegates and Observers to sign their names on the F.A.I. Register.

II. APPROVAL OF MINUTES OF THE LAST MEETING (26/27.11.1975)

These minutes were approved.

III. REPORT BY THE PRESIDENT OF CIVL

Mr. Dan Poynter, President, commented as follows :

Since the CIVL is a young organization, most of our background is recent history. The Organization Manual distributed with the Agenda was prepared by Mr. Robb, USA, Secretary CIVL, to record the decisions of the Delegates at the last CIVL Plenary Meeting.

The first World Hang Gliding Championships in Kössen, with 25 participating nations must set a record for a first official championship. This CIVL Meeting with Delegates from 17 countries, and Observers from these and 3 additional countries demonstrates the current interest in hang gliding.

Hang gliding and the CIVL are bringing new members into the F.A.I., and are causing some NAc's to pay their past-due F.A.I. contributions.

This is the finest collection of hang gliding experts ever assembled. The Sub-Committee Chairmen who met with all interested Delegates on the previous day are doing a fine job of making recommendations for the advancement of the sport to keep pace with the technological developments of the manufacturers, and the flying capability of the competitors.

Three Memos had been distributed by the President since the last meeting. One important change in Hang Glider Class Specifications was made to promote flying safety in design for the 1976 World Championships. One had come a long way in two years, but there was still a lot to do. Working for and with CIVL and the FAI was exciting because the sport of hang gliding was rediscovering aviation.

IV. UNFINISHED BUSINESS

- a) National Official Observers: Report by Mrs. Ann Welch (United Kingdom) (see Annex 1)
- b) Insurance - Mr. Sepp Himberger.
No pattern of insurance has developed. Austria has individual insurance. France has accident insurance through normal channels. United Kingdom has third party insurance. Lloyds of London offers insurance through recognized official organizations with responsible control. USEGA is negotiating liability insurance for \$5.00 per year if sufficient members participate. Spain has \$5.00 per year Air Sport Insurance through its NAc.

It was agreed that Mr. Himberger would act as Chairman of the Insurance Sub-Committee for 1976-1977.

V. REPORTS BY CHAIRMEN OF SUB-COMMITTEES

- a) Accident Review Board. Report by Mr. Juan Garcia (Denmark).
There had been no interchange of information during the past year.

The Instructor Certification Program of USHGA, written by Mr. Dennis Pagen, and the new Hang Glider Manufacturers Association Performance Specifications have been submitted by US Delegate Mr. Harry Robb. Mr. Robert Wills, monitor of the USEGA Accident Review Program, had submitted an analysis of hang glider accidents to date. This information was available to all Delegates.

President Dan Poynter proposed and the Committee agreed to establish three Sub-Committees :

1. Manufacturing Standards, Mr. Juan Garcia (Denmark)
2. Accident Data Collection and Analysis, Mr. Roman Camps (Spain).
3. Training Methods and Training Safety, Mr. Bernard Berthou (France).

- b) Judges Program

A complete document for setting up a panel of Judges was presented and discussed. A few changes were considered and accepted.

Motion : To accept the document as amended. PASSED. (See Annex 2)

Mrs. Ann Welch moved that the CIVL Bureau review the document and that it then be incorporated in an Annex to the Sporting Code, Section 7.

The Motion was voted and passed.

Mr. Bernard Berthou reported that the FFVL had a Judges Training License Program that was available to anyone requesting a copy.

- c) and Proficiency Standards and Proficiency Badge Design, Mrs. Ann Welch (U.K.)

d)

Mrs. Welch reviewed the current International Badge rating requirements.

Motion : To delete the words "Ground clearance must be at least 100 meters" in para. : 2.1.1. of the Sporting Code Section 7

Motion Passed.

Rating requirements for a second, more advanced badge proposed by Mr. Vic Powell, USA, Chairman of the Proficiency Standards Sub-Committee were presented by Mrs. Welch.

Motion : To amend the proposal to allow requirements to be accomplished in one, two, or three flights. Motion voted and passed.

Mrs. Welch proposed that three International Delta-shaped badges be adopted as the FAI Proficiency Badges. A drawing of the badge was distributed. The 1976 FAI International Badge would become the International Delta Bronze. Two additional badges, to be called Delta Silver and Delta Gold, were proposed. The FAI International Delta Silver Badge would be awarded for the new proficiency standard. (See Annex 3 for review of badge design and rating requirements).

Motion : To adopt the FAI Badge design as presented.

Motion voted and passed.

Mrs. Welch proposed that the first 100 Delta Silver Badges be issued from FAI, be numbered, and the names of the pilots be entered in an International Register. After the first 100 Badges, each NAEC would direct the manufacture and issue of the Delta Silver Badge, and Bronze Badges.

Motion : To accept the proposal. Motion voted and passed.

Mrs. Welch proposed that the FAI International Delta Bronze Badge, when available, should be awarded to each contestant listed in the Official Final Results of the 1976 World Championships.

Motion : To adopt the proposal. Motion voted and passed.

Mrs. Ann Welch accepted Chairman of Proficiency Badge Design Sub-Committee for 1976-1977.

After lunch, the Meeting was reconvened and President Dan Poynter expressed his thanks to the Mayor of Kössen for the lunch invitation.

Motion : To make the expression of thanks a formal resolution of the CIVL Delegates. Motion voted and approved.

f) Tow Launching Report, Mr. Alf Eriksson (Sweden)

Mr. Eriksson summarised the discussion of the sub-committee meeting on the previous day as follows :

1. Information should be exchanged between all interested Delegates by means of articles in hang glider magazines in each country.
2. Information should cover the following areas :
 Hang glider specifications for safe towing.
 Proper tow vehicles and towing equipment for the vehicle and glider.
 Specifications for tow lines, safety bridles, safety releases.
 Preflight planning and equipment inspection.
 Towing techniques for the tow boat driver and safety-releaseman.
 Towing techniques for the pilot of the hang glider.
 Instruction methods and techniques.
 Flying safety "Do and Don't" suggestions.
3. Request that the Organizers of the 1977 World Championships in South Africa include a seminar or some activity of tow launching in their program.
4. Reference was made to the document on tow launching for hang gliding which was distributed to all Delegates.

Motion : To request the Organizers of the 1977 World Championships in South Africa to include a seminar on tow launching, and, if possible, demonstrations of land tow launching for all interested persons. Motion voted and passed.

Mr. Rod Murphy responded that the proposal and motion would be included in the planning of the program.

h) World Records Sub-Committee Report, Mr. Martin Hunt (United Kingdom)

It was reported that no adverse comments had been received on the World Records portion of the FAI Sporting Code Section 7, and it was recommended that the document remains as written.

President Dan Poynter appointed Mr. John Farnan (Canada) to monitor the program and make recommendations for any necessary changes.

VI. NEW BUSINESS

- a)- Hang Glider Competition Classes, Mr. Mike Harker (Federal Republic Germany)
 Revised standards for three competition classes of hang gliders in World Championships were presented after having been coordinated with Delegates by Mr. Mike Harker and Mr. Harry Robb.

There was discussion on a number of points, and amendments were offered to clarify several items. The program was tabled for presentation after modifications were made. At a later stage the document as amended was presented.

Motion : To accept the document as amended. Motion was voted and passed.
 (see Annex 4)

- Modified Tasks for World Championships Rules, Mr. Mike Ollive (South Africa)

Mr. Ollive explained that in examining the required changes to the current World Rules, it was deemed necessary to effect a complete reorganization to include the necessary changes and additions, based on the experience gained in the current World Championships.

During the discussion, several amendments were suggested.

The Deputy Director General then explained that FAI Rules and procedures were based on the assumption of a minimum duration of Sporting Codes of four years. Only limited exceptions to that principle could be accepted. This was one of the basic working conditions of the organization and it was designed to avoid instability and confusion. This principle applied to Championship rules as well as other provisions in the Codes.

After considerable discussion and a recess, President Dan Poynter moved that the discussion be tabled for further work and presentation later in the meeting. The motion was voted and passed.

- b) Extension of the Sporting Code to include World Rules, Mr. Martin Hunt (U.K.)
Inclusion of the World Rules in the Sporting Code Section 7, as printed by FAI has superseded this item.

- c) and d) Boat Tow Launch, Mr. Harry Robb, U.S.A.

Printed copies of the USHGA Official Tournament Rules had been mailed to most Delegates earlier. Additional copies were supplied at this time. Mr. Robb explained that the Rules had been developed from four years of international level boat-tow launch competitions at Cypress Gardens, Florida, USA. They have proved very adequate in providing guidance in all situations for the flyers and judges.

During the discussion, Mr. Robb suggested that the subject: "Bid for a 1978 World Cup" be incorporated in the discussion. A package of information had been mailed to most of the Delegates earlier, or was made available.

After much discussion, the following motion was proposed:

Motion: To establish a working group authorized to sanction World Cup boat-tow launch competition, based on the USHGA Rules, and to report to CIVL on the results. Mr. Robb (USA) to be Chairman.

After considerable discussion pro and con on the advisability of CIVL becoming involved in tow launch activities, Mr. Poynter asked if the Delegates were prepared to vote.

A motion to vote was voted and passed. The motion was voted and passed.

- e) Establishment of a Technical Committee, Mr. Sepp Himberger (Austria)
Mr. Himberger declared that the idea of a Technical Committee was adequately included in the new Safety Committee Program.

- f) Automatic Qualification of Previous World Champions

Mr. Farnan (Canada) offered the idea that the first 3 places in each class be invited by the Sponsors of the World Championships to attend and defend their titles. There was much discussion pro and con on the advisability of preempting this decision from each country involved. It was suggested that only the winner in each class be invited. It was suggested that each country should have the option and responsibility of including previous World Champions on their National World Team without qualification the year of the World Championships, or of requiring each member of the Team to qualify in accordance with the system in force in the country that year.

Motion: The 1-2-3 winners in each Class in this competition should be invited to defend their titles as individuals in the next World Championships.

Motion was voted and defeated.

- g) CIVL Promotion and Finances, Mr. Martin Hunt (U.K.)
After the presentation, Mr. Larcher, FAI, offered to explain FAI Finance procedures. Thereafter, Mr. Hunt suggested that his report be withdrawn.

- VI.a) (continued) The new Tasks and Annex on Scoring were presented.

After some discussion, it was proposed that the 1977 CIVL Bureau review and prepare the final version for future use.

Motion: To accept the document as presented for review by the CIVL Bureau for later publication by CIVL. Motion was voted and passed.

VI. a) (continued)

Revised World Championships Rules were presented by Mr. Mike Ollive.

Motion : To adopt the Rules as amended and presented.

Mr. Larcher, Deputy Director General of FAI, explained that the Sporting Code Section 7 Hang Gliders was to be presented to the General Conference at Teheran in October 1976. As a rule, Sporting Code Sections remain valid for a minimum of four years. Therefore a general revision of Championships rules in Section 7 could only take place at a later stage.

Motion : To accept the complements and modifications to the Sporting Code ~~Sec.~~ 7 as proposed for reference to the CIVL Bureau and Mrs. Ann Welch for further study and refinement. Final consultation on procedures to be followed will be arranged with the General Directorate of F.A.I.

Motion was voted and passed.

VII. WORLD CHAMPIONSHIPS

a) 1977 World Championships, Status Report, Mr. Rod Murphy, South Africa. Mr. Murphy, Representative of South Africa for the 1977 World Championships read a status report on the details of planning for the FAI World Championships at Barberton, South Africa (8-22 October). No problems in providing a good flying site with adequate accommodation for all personnel were anticipated. The report was accepted by the CIVL Delegates as confirmation of South Africa as Host and Sponsor of the 1977 World Championships in Hang Gliding (see Annex 5).

Entry fees were estimated to be between 600 and 900 US\$ including transport, accommodation and breakfast.

All FAI Members would be admitted without exception.

South Africa would undertake at its own expense the printing and circulation in English and French of the Annex to be added to Section 7 of the Sporting Code.

b) 1979 World Championships

Mr. Bernard Berthou (France) confirmed his bid for the 1979 World Championships for France. He requested information on the deadline for confirmation of location and dates of the Championships.

Mr. Larcher, FAI, declared that the following information should be submitted at the next CIVL Meeting in 1977 :

IX. DATE AND PLACE OF NEXT MEETING



F.A.I. OFFICIAL OBSERVERS

=====

1. AUTHORITY

In accordance with the F.A.I. Sporting Code, Section 7, dated 1976, Section 2.3.1, official control of World Record and of FAI Proficiency Ratings shall be effected by Observers approved by or acting on behalf of an NAeC.

2. QUALIFICATION

Official Observers shall possess, as a minimum, the FAI International Delta Bronze Badge, or the equivalent rating of their NAeC, be persons of integrity and honor, and thoroughly understand the FAI Sporting Code to do their job carefully and properly, in observing and certifying records and ratings.

3. APPOINTMENT

- 1. Official Observers may be appointed by the NAeC or its delegated representative such as a National Hang Gliding Association.
- 2. The number of Official Observers and the term of the appointment shall be determined by each NAeC. Appointments may be withdrawn for cause.
- 3. Assistants for observation of any flight shall be appointed by the Official Observer as required.

F.A.I. INTERNATIONAL JUDGES PROGRAMC.I.V.L. (HANG GLIDING)1. PANEL OF INTERNATIONAL JUDGES

1. At any World Hang Glider Championships, all activities which concern the Starting, Observing, Judging and Scoring of the competitors' performance, shall be carried out by a Panel of FAI International Judges.

2. QUALIFICATIONS FOR FAI INTERNATIONAL JUDGES IN HANG GLIDING

1. The NAeC must certify that the proposed Judge is competent to be an International Judge based on experience and training in the use of timing equipment and in judging hang gliding competition at two National and one International Championships (International may substitute for National Meets), in the following capacities :
 - A. Meet Director or Assistant Meet Director
 - B. Start Judge
 - C. Landing Judge
 - D. Pylon or Gate Judge
 - E. Measurer
 - F. Timer
 - G. Scorer
2. However, persons who hold Parachuting or other aeronautical International Judges Licenses need only fulfill the above duties at one National Championships to qualify for the International Hang Gliding Judges License.

3. APPOINTMENT OF INTERNATIONAL JUDGES

1. Forty five days prior to the CIVL Plenary Meeting which precedes the World Championships, each NAeC shall submit to the FAI the names of their qualified International Judges who are able to serve at the World Championships.
2. At the CIVL Meeting, the World Championships Organisers shall state how many International Judges are required for the conduct of the competition. Each Delegate may then nominate one Judge plus an alternate from the approved list. If the number of Judges exceeds the requirement, a vote will be taken to determine the Judges accepted by CIVL for the competition. If fewer than the required Judges are nominated, the Organisers may invite additional National Judges from their own or other NAeC's.

4. SELECTION OF THE CHIEF JUDGE AND ASSISTANT CHIEF JUDGE

1. From the panel of Judges accepted for the competition, the Organisers shall nominate two persons for the position of Chief Judge to be selected by vote of the Delegates. In the event of failure of the Chief Judge to accept the position, the second nominee and the Assistant Chief Judge shall be invited to serve as Chief Judge in that order.
2. After the selection of the Chief Judge, the Delegates may nominate any other judges for Assistant Chief Judge, to be selected by vote of the Delegates. In the event that he has to assume the position of Chief Judge, the Organisers shall in consultation with the President of CIVL and the Chairman of the Jury, appoint an Assistant Chief Judge.

3. The Chief Judge and the Assistant Chief Judge may not be of the same nationality.

5. THE CHIEF JUDGE DUTIES

1. Apoint a Task Judge for each Task of the competition.
2. Control the correct starting, timing, judging, scoring of the Championships in accordance with the Sporting Code.
3. Advise the International Jury of any Protests or matters relating to Interpretation of Rules which need to be decided.
4. Convene the International Jury to consider any matter which falls within their jurisdiction.

6. THE ASSISTANT CHIEF JUDGE DUTIES

1. Assist the Chief Judge in his duties.
2. To deputise for him in his absence, and as otherwise required.
3. Act as liaison with the Sporting Director and the Organisers.

7. TASK JUDGES

1. The Task Judges shall be appointed by the Chief Judge in consultation with the Sporting Director.
2. Their duties shall be to directly control and manage the timing, measuring, judging, and scoring of the Task under their control.

8. DISQUALIFICATION OF INTERNATIONAL JUDGES

If, during the course of the World Championships, it becomes apparent to the Chief Judge that any International Judge is failing in his duties, or is incompetent, the Chief Judge may suspend the Judge pending confirmation by the International Jury. If the Jury confirms the suspension, it shall continue for the next two World Championships. In addition, the NAeC of the suspended Judge shall be prohibited from nominating further International Judges for the same period.

9. ACCOMMODATION OF THE PANEL OF INTERNATIONAL JUDGES

The accommodation, food and local transport of the Judges shall be provided by the Organisers, and they shall not pay Entry Fees.

F.A.I. INTERNATIONAL PROFICIENCY STANDARDS AND BADGES FOR HANG GLIDING

1. GENERAL

1. The International Proficiency Badge program was designed to test the pilot's proficiency by requiring him to demonstrate the minimum skills considered necessary to safely fly in international competition.
2. The Rating Badge qualifies the holder to participate in open hang gliding competitions and shall be valid in all countries represented by the F.A.I.
3. Ratings shall be valid for a lifetime.

2. INTERNATIONAL PROFICIENCY BADGES

1. Since the delta shape has become the internationally recognized symbol for hang gliding world wide, it was chosen for the basic element of the design of three proficiency level badges, as follows

FAI International Delta Bronze	Bronze		Light/mid
FAI International Delta Silver	Silver		Blue Delta
FAI International Delta Gold	and Gold		
2. Badges could be manufactured by FAI, by any country, or purchased from any country producing them
Circular Wreaths 1 - 1.5 cm diameter

3. ADMINISTRATION

1. Ratings are administered by the National Aero Clubs (NAeC) or their designated affiliate, i.e. National Hang Gliding Association. If a flyer is a national of a country having no NAeC, the NAeC of the country controlling the flight shall register the ratings, and a rating may be made in any country in the World.
2. FAI International Proficiency Badges are issued to flyers who satisfy requirements established for each rating.
3. The flyer is responsible for insuring the completeness of all forms and paperwork, and forwarding it to the NAeC.

4. CERTIFICATION PERSONNEL

1. Official Observers appointed by the NAeC must possess the FAI International Delta Bronze Badge or the equivalent NAeC rating, as a minimum requirement. Assistants may be appointed by the Official Observer.
2. The Official Observer for rating may be of the country of the flyer, or of the country in which the flight is carried out, at the flyer's discretion. An Official Observer may not act in such capacity for any rating attempt in which he is the flyer or passenger.
3. The Official Observer must personally witness and certify the rating flight maneuvers of the flyer.

5. FAI INTERNATIONAL DELTA BRONZE BADGE RATING REQUIREMENTS

1. A distance of not less than two (2) kilometers must be flown over a course marked by two pylons not less than one-half (1/2) kilometer apart, terminating with a controlled landing. The course requires two 90 degree turns, and three 180° turns, with a controlled landing within 25 meters of a designated point.

(The skills required to fly the course conform in a reasonable manner to those outlined in the USHGA Hang 3 Rating.) This is the minimum level of experience any flyer should have before attempting to fly an unfamiliar mountain site.

6. FAI INTERNATIONAL DELTA SILVER BADGE RATING REQUIREMENTS

1. A distance of not less than fifty (50) Kilometers (31 miles) must be flown in a cross country flight.
A height of not less than 1 000 meters (3 300 feet) must be gained above the launching height.
A time of not less than 5 hours must be acquired in a duration flight.

The above may be performed separately or on the same flight.

7. FAI INTERNATIONAL DELTA GOLD BADGE RATING REQUIREMENTS

1. Requirements for this rating have not been established at this time.

8. SPECIAL ISSUE DECISIONS BY CIVL

1. The FAI International Delta Bronze Badge, when available, shall be awarded to each contestant listed in the Official Final Results of the 1976 World Championships.
2. The first 100 Delta Silver Badges to be awarded would be issued from FAI Headquarters in Paris, and entered on an Official International Register.

A. GENERAL

- 1. Flight instruments are permitted in all Classes.
- 2. Communication devices are prohibited in all Classes.
- 3. Specifications and airworthiness certificates, or equivalent, required in each Class for each glider.

B. COMPETITION CLASS 1

- 1. The frame shall consist of four structural components which include two leading edge spars, one keel spar, and one ~~cross~~ spar. The cross spar may be in two sections. Spars may not have performed bends.
- 2. Flexible surface aerofoil.
- 3. Pilot weight-shift control only, aerodynamic controls prohibited, including spoilers.
- 4. Maximum aspect ratio shall be 4.5.
- 5. Minimum wing loading shall be 5.00 kg/m² (1.00 lb/ft²)
- 6. Capsule or partial capsule fairing of pilot is prohibited.

C. COMPETITION CLASS 2

- 1. Flexible surface aerofoil.
- 2. Pilot weight-shift control only, aerodynamic controls prohibited, including spoilers.

D. COMPETITION CLASS 3

- 1. Rigid surface aerofoils and aerodynamic controls are permitted.

E. NOTES :

- 1. Any item is permitted if not prohibited.
- 2. Wing loading calculation shall be take-off weight.
- 3. Sail area shall be projected sail area. (Surface area.)
- 4. Aspect ratio is wing span² /projected sail area. (Surface area.)
- 4. Aspect ratio will be measured for winning placements only at end of competition. Gliders not meeting specifications will be disqualified.
- 5. Class 3 tasks shall be suited to the higher L/D of Class 3 Gliders
- 6. Flexible surface aerofoil is one which does not retain its flight configuration at rest.
- 7. Any physical means to produce energy to increase performance will not be allowed.

SUMMARY OF DECISIONS BY C.I.V.L.

1. An International Judges Qualification Program has been established. National Judges will be nominated in accordance with the qualifications outlined in the program, to serve as Officials in World Championships. Service will be voluntary and without remuneration by the host country.
Mr. Rod Murphy (South Africa) is Chairman of the 1977 Committee.
2. Each National Hang Gliding Association shall be responsible for establishing qualifications for National Official Observers to monitor and certify World Record Attempts, and FAI Proficiency Badge Ratings.
3. World Record Attempts are to be made in accordance with FAI Sporting Code, Section 7 Hang Gliders 1976, as previously established.
Mr. John Farnan (Canada) will monitor the program and propose new ideas.
4. The 1975 proposed International Badge program was never implemented. It is now expanded to include 3 levels of flying proficiency - International Delta Badges in Gold, Silver, and Bronze. When made available, the Delta Bronze Badge was voted by the Delegates to be awarded to each contestant listed in the Official Final Results of the 1976 World Championships. The first 100 Delta Silver Badges to be awarded will be issued from FAI Headquarters in Paris and entered on an Official International Register. Thereafter, each country may manufacture and issue the International Delta Silver Badge in accordance with the flying proficiency requirements.
Mrs. Ann Welch (United Kingdom) is Chairman of the 1977 Committee.
5. A few countries reported availability of economical public liability and personal accident insurance, but most countries reported continuing difficulties with this problem. Mr. Martin Hunt (United Kingdom) reported that Lloyds of London insures national organizations with responsible control programs, and recognized by their National Aero Club.
Mr. Sepp Himberger (Austria) is Chairman of the 1977 Committee.
6. Accident Prevention Program. Chairman Juan Garcia (Denmark), acknowledged receipt of the US HGMA construction specifications, and the New Performance Specifications as proposed, plus the USHGA Instructors Certification Program by Mr. Dennis Pagen, provided by US Delegate Mr. Harry Robb. Also, Accident Data Analysis had been received from Mr. Robert Wills, Sr. representing the USHGA Accident Reporting Program. No interchange of information had been accomplished between Delegates of all countries.
A request for additional published information relative to Training and Safety from any source was addressed to all Delegates. An expanded Committee was formed :
 1. Manufacturer Standards, Mr. Jean Garcia (Denmark).
 2. Accident Data Collection and Analysis, Mr. Roman Camps (Spain).
 3. Training Methods and Training Safety, Mr. Bernard Berthou (France).
7. Boat-tow launch hang glider demonstration flights by Messrs. Bill and Steve Moyes were presented for all Delegates at Walchsee lake near Kössen.
8. Authority was voted to establish a working group with the Tow Launch Committee to schedule a World Cup Competition in 1977 at Cypress Gardens, Florida, governed by the USHGA Boat Tow Launch Official Tournament Rules. A report will be made to FAI and CIVL on the results of the meet for consideration of establishing a World Championship in tow launch hang gliding. Other international competitions will be encouraged. Note : An International Competition is planned at Santiago, Chile, in March 1977.
Mr. Harry Robb (USA) is Chairman of the 1977 Committee.

9. Rod Murphy, Alternate Delegate and South Africa Representative for the 1977 World Championships, presented a status report on the details of planning for the FAI World Championships at Barberton, South Africa, (8 through 22 October 1977). The report was accepted by the CIVL Delegates as confirmation of South Africa as Host and Sponsor of the 1977 FAI World Championships in Hang Gliding.
10. France reaffirmed its formal bid as Host for the 1979 FAI World Championships which was generally accepted. The United Kingdom made a provisional bid for the 1981 World Championships.
11. Modifications and or additions to World Rules for the 1977 World Championships will be further considered by the CIVL Bureau, before submission to FAI for publication as additions to, and interpretation of, the current World Championship Rules. The proposals approved by the CIVL Delegates are as follows :
 1. Additional Tasks for Competition Class 1 and 2.
 2. Special Tasks for Competition Class 3.
 3. Rotation of launch take-off Order of Flying.
 4. Defined launch take-off refusal options.
 5. Landing interference reflight for landing score only, not flight score.
 6. Multiple zone target accuracy landing replaces precision measurements.
 7. Landing quality relates only to landing score, not to flight score, however landing must still be made in Landing Zone to validate flight score.

Mr. Harry Robb (USA) is Chairman of the 1977 Committee.

13. Modification of the World Competition Class Specifications was extensive to allow for the normal evolution of glider design in future years.
